WHEREAS, the U.S. Department of Housing and Urban Development, acting on behalf of Federal Housing Administration and Veterans Administration, has determined that the annexation is in accord with the general plan previously approved by them and desires to consent to the proposed annexation.

NOW, THEREFORE, pursuant to the powers reserved in the Declaration, Friendswood declares that the following described land (the "Land") is annexed into the Association and is subjected to the Declaration:

All of Fairfield Inwood Park Section Three, a subdivision of Harris County, Texas, according to the map or plat thereof recorded in Volume 34%, Page 146 of the Map Records of Harris County, Texas.

Pursuant to Article V, Section 12 of the Declaration, the U.S. Department of Housing and Urban Development joins in the execution of this instrument to indicate the approval of the Federal Housing Administration and the Veterans Administration to the Annexation.
